ORDER

As per the Govt Order read above, Government had accorded Administration sanction for 2 projects under NABARD TRANCHE XXVIII ie "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur", for an amount of Rs.461.33 lakh and the Construction of Multi - Species Fish Seed Farm at Chengulam Darm site in Idukki District" for an amount of Rs. 654.95 lakh under the H/A 4405-00-104-53(P) with in the project completion period.

2) As per the letter read above the Director of Fisheries has furnished the drawal application under Rural Infrastructure Development Fund -Tranche XXVIII, in the prescribed proforma towards the reimbursement claim of the projects "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur " implemented by Matsyafed, incurred from August 2024 to November 2024 for an amount of Rs. 22.13150 lakh and the "Construction of Multi - species Fish Seed Farm at Chengulam Dam site in Idukki District", for an amount of Rs. 42.66806 lakh. implemented by Harbour Engineering Department, for the period from 01/08/2024 to 30/11/2024 and has requested to accord sanction to release fund in this regard.

2. Government examined the matter in detail and are pleased to accord sanction to release a sum of Rs. 63,68,956/- (Rupees Sixty three lakh Sixty eight thousand Nine hundred and Fifty six only) towards the reimbursement claim for RIDF Tranche XXVIII for two projects, Construction of Multi - species Fish Seed Farm at Chengulam Dam site in Idukki District amounting Rs. 42,66,806/-implemented by Harbour Engineering Department and Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur, amounting Rs. 21,02,150/- excluding state share as per circular No. 76/2016/Fin Dated 09.09.2016, implemented by Matsyafed under the H/A 4405-00-104-53(P).
