ORDER

In the Annual Plan Budget for 2024-25, a total amount of Rs.14,50,00,000/- was allocated for the implementation of the Scheme-'Cochin Cancer Research Centre (CCRC)' under the Head of Accounts '2210-05-200-92-35-(P) - CCRC - Grants for the creation of Capital Assets' (Rs.8,37,00,000/-) and '2210-05-200-92-36-(P) - CCRC - Grant in aid - General - Non Salary' (Rs.6,13,00,000/-). As per Government Order read as paper 2nd above, Administrative Sanction was accorded for the implementation of the Scheme - Cochin Cancer and Research Centre (CCRC) at a total cost of Rs.13,50,00,000/-(Rupees Thirteen Crore and Fifty Lakh only), by meeting the expenditure under the Head of Account '2210-05-200-92(P) - Cochin Cancer and Research Centre, Ernakulam' from the budget provision for the financial year 2024-25, subject to re-appropriation Rs.3,87,00,000/- from the head of account '2210-05-200-92-35(Plan)' to the head of account '2210-05-200-92-36-(P)'. Earlier as per Government Order read as paper 1st above, the resumed amount of Rs.66,71,983/-(Rupees Sixty Six Lakh Seventy One Thousand Nine Hundred and

Eighty Three only) was reallocated to Cochin Cancer Research Centre, under the head of account '2210-05-200-92-35(PV)' from the budget provision for the Financial Year 2024-25. Again as per the Government Order read as 3rd paper above a total amount of Rs.2,00,00,000/-(Rupees Two Crore Only), one crore each under the head of accounts '2210-05-200-92-35(Plan)' and '2210-05-200-92-36-(P)', was released out of the Administrative Sanction amount.

2. Meanwhile as stipulated in the Government Orders read as papers 4th and 5th above, CCRC has furnished prioritization proposal, wherein Rs.9,30,00,000/- was prioritized out of the AS amount and further deferment of the remaining Rs.1,00,00,000/- for which Administrative Sanction was not given, computing to an overall plan cut of 36%.

Again as per the letter read as paper 6th above, the Director, CCRC has requested to release the balance plan provision of Rs.6,63,28,017/-under the head of account '2210-05-200-92(PV)', for the smooth implementation of the plan schemes.

3. Government have examined the matter in detail. Accordingly sanction is hereby accorded to release a total amount of Rs.4,38,00,000/- (Rupees Four Crore Thirty Eight Lakh only) to Cochin Cancer and Research Centre as noted below, for the implementation of plan schemes, subject to the conditions that follows
