- Dr. Pullumpilil Thomas Alexander, then working as Associate Professor in the Department of Neurological Sciences at Christian Medical College, Vellore was appointed as Neurologist in ICCONS as per Government Order read as paper 1st above, for a period of one year, with a remuneration of Rs 1.6 lakh per month, as recommended by the 41st Executive Committee meeting of ICCONS held on 21.10.2022.
- 2. As per the letter read as paper 2nd above, the Director (i/c), ICCONS informed that Dr. P.T.
