## **ORDER**

As per G.O read as paper 1<sup>st</sup> above Administrative Sanction was accorded for an amount of Rs 115 lakh for the Construction of Pre-Matric Hostel (Male) at Nenmini, Thachinganadam in Malappuram District, under Scheduled Castes Development Department.

- 2. The land was handed over to the Public Works Department on 15.10.2019 and the roof, slab and masonry works of the ground floor of the hostel building, which is planned to be a three floor building as per the topography, have been completed. The Director of the Scheduled Caste Development Department has informed that the construction work cannot be completed with the allocated amount. As per the 2<sup>nd</sup> paper read above, the Director, Scheduled Castes Development Department has requested to accord Administrative Sanction for the revised estimate of Rs. 3,50,00,000/- (Rupees Three Crore Fifty Lakh Only) for expending the amount from the Head of Account 4225-01-800-89(Plan), submitted by the Executive Engineer , Public Works Department .
- 3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the revised estimate of Rs.

3,50,00,000/- (Rupees three crore fifty lakh only) for the construction of Pre-Matric Hostel (Male) at Nenmini, Thachinganadam in Malappuram District, under Scheduled Castes Development Department by meeting the expenditure from the Head of Account 4225-01-800-89(Plan) subject to the following conditions;

- i. Quantity of the reinforcement shall be Properly worked out by the TS authority before issuing TS.
- ii. The provision of lift for G+2 structure shall be reviewed by the TS authority.
- iii. The TS authority shall verify and ensure that the provisions proposed in project is at par with the requirement of number of proposed occupants and any possibility of reduction in cost of the overall project shall be exercised while issuing TS.
- iv. The provisions, quantities and rates shall be verified and confirmed by the TS authority.
- v. A copy of approved Technical Sanction Estimate with supporting documents shall be forwarded to the Finance inspection [Technical] department for concurrence.
