### ORDER

As per the G.O read as 1<sup>st</sup> paper above, Government have released Central and State share for the CSS National Programme for Prevention and Management of Burn Injuries (NPPMBI)" at Government Medical College, Kottayam. As per the G.O read as 2<sup>nd</sup> and 3<sup>rd</sup> paper above, Government have accorded Administrative Sanction for an amount of ₹.64,57,000/- for the setting up of Skin Bank at Government Medical College, Kottayam. As per the letter read as 4<sup>th</sup> paper above, the Director of Medical Education has reported that there is a balance amount of ₹.67,17,961/- and hence has requested to accord permission to use the remaining amount of ₹54,16,000/- for the purchasing of essential equipment for the Burns Unit.

2) Government have examined the matter in detail and are pleased to accord permission to utilise an amount of **₹.54,16,000/- (Rupees Fifty Four Lakh Sixteen Thousand only)** for the procurement of essential equipment for the Burns Unit at Govt. Medical College Kottayam, as detailed below;
