ORDER

The Chairman & Managing Director, KSRTC in his letter read as 1st paper above, has requested for administrative sanction for the project "Construction of 4 bay Garage with Inspection Pit at Cheruthoni Phase-I" amounting to Rs.2 crore. Accordingly as per the Government Order read as 2nd paper above, administrative sanction was accorded with the condition that a copy of the TS estimate to be submitted to Government for approval. The Chairman & Managing Director, KSRTC in his letter read as 3rd paper above, has submitted the TS Estimate for "Construction of 4 bay Garage with Inspection Pit at Cheruthoni Phase-I" project for approval.

2. Government have examined the matter in detail and are pleased to approve TS estimate for the Rs. 2 crore "Construction of 4 bay Garage with Inspection Pit at Cheruthoni Phase-I" project subject to the following conditions:

1. The TS authority may explore the possibility of providing steel structure (instead of R.C.C frames structure) keeping economy and safety points of view.

2. TS authority shall ensure the structural adequacy and structural stability of the proposed building structure constructed in first phase of

the project before issuing the Technical Sanction.

3. The correctness of the rates adopted for the observed data included in the estimate, shall be ensured by the TS authority.

4. The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.

5. Electrical work detail estimate shall be included in the TS estimate and place before TS Authority.
