ORDER

The Hon'ble Kerala Administrative Tribunal at Thiruvananthapuram (Additional Bench, Ernakulam) in its final order dated 22.11.2024 in OA(EKM)-1524/2024 filed by Shri.Sanooj Rinfan K.H., Clerk (Under Suspension), Govt. Homoeo Hospital, Manjeri, Malappuram has ordered as follows;

"Accordingly, the Original Application is disposed of with a direction to the 1st respondent (Secretary, AYUSH) to consider Annexure A14 appeal and pass appropriate orders, after affording an opportunity of personal hearing to the applicant, at the earliest, at any rate within a period of two months from the date of receipt of a copy of this order."

Annexure A14, the Appeal memorandum dated 30.10.2024 of the petitioner was received in Government on 20.11.2024 and the same has been forwarded to the Director(i/c) of Homoeopathy for report on 23.11.2024 . Meanwhile, the petitioner filed a case before the KAT and Hon'ble court delivered the final order dated 22.11.2024 itself. As per the direction of the Hon'ble KAT, Deputy Secretary heard the petitioner on 17.01.2025.

After hearing the petitioner and the senior officials of Homoeopathy Department, it is revealed that Government can be able to take a final decision

in the Appeal petition (**Annexure A14**) only if the authenticity of the Office Order, said to be issued stating that the amount due to the H.M.C. fund has been received into the personal account of the petitioner, is revealed. Therefore, the Crime Case No.1092/2024, currently being registered and investigated at Manjeri Police Station in Malappuram district on alleged matter has to be completed. Home Department has been requested for the investigation report at the earliest.

In the above circumstances, the petitioner's Appeal petition (**Annexure A14**) can be disposed of in the light of the findings in the police report in Cr.No.1092/2024 of Manjeri Police Station. The Director of Homeopathy being the Appointing authority of the petitioner can take a decision in the light of the advice of the concerned police officers regarding reinstatement of the petitioner.

Thus the final order dated 22.11.2024 of the Hon'ble KAT in OA(EKM)No.1524/2024 filed by Shri.Sanoj Rinfan K.H., Clerk, Govt.Homoeo Hospital, Manjeri, Malappuram is complied with.
