The hostel operates under the jurisdiction of the Kalpetta Project Officer , Scheduled Tribes Development Department.

(2) The State Level Working Group held on 22/12/2025 considered the proposal and recommended approval of the same , subject to the condition that the Director, Scheduled Tribes Development Department shall assess the age and structural condition (fitness) of the building and ensure that the maintenance expenditure is economically justified.

(3) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the Project proposal for painting and tile work of Prematric Hostel, Kaniyambatta at an estimated cost of ₹11,16,000/- (Rupees Eleven Lakh Sixteen Thousand Only) ,subject to
