The Director, Scheduled Tribes Development Department as per the letter read above has submitted a proposal for Renovation works of Prematic Hostel (Boys),Mambad at an estimated cost of ₹29,70,000/- (Rupees Twenty Nine lakh Seventy Thousand Only) to Government for placing before the State Level Working Group Committee.
