ORDER

The Director, Scheduled Tribes Development Department as per the letter read above has submitted a proposal for Running of Mobile Medical Clinics (14 numbers) through Kerala Medical Services Corporation Ltd. in various districts (except Alappuzha & Kottayam districts) for three years at a total cost of ₹14,97,23,189/- (Rupees Fourteen Crore Ninety Seven Lakh Twenty Three Thousand One Hundred and Eighty Nine Only) to Government for placing before the State Level Working Group Committee.

(2) The State Level Working Group held on 22/12/2025 considered the proposal and recommended approval of the proposal for running of Mobile Medical Clinics (14 numbers) in various districts (except Alappuzha and Kottayam) for three years , subject to the condition that the Director, Scheduled Tribes Development Department shall take necessary steps to ensure that the patient data are entered at the time of consultation itself and verified at appropriate intervals and to be linked to E-health.

(3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for
