ORDER

The Director, Scheduled Tribes Development Department as per the letter read above has submitted a proposal for the renovation works of Toilet block in the Girls Hostel of the IGMRS, Nilambur at an estimated cost of ₹39,90,000/- (Rupees Thirty Nine Lakh Ninety Thousand Only) to Government for placing before the State Level Working Group Committee.

(2) The State Level Working Group held on 22/12/2025 considered the proposal and recommended approval of the same , subject to the condition that the Director, Scheduled Tribes Development Department shall assess the age and structural condition (fitness) of the building and ensure that the maintenance expenditure is economically justified.

(3) Government have accepted the recommendation of the State Level Working group and are pleased to accord Administrative Sanction for the renovation works of Toilet block in the Girls Hostel of the IGMRS, Nilambur at an estimated cost of ₹39,90,000/- (Rupees Thirty Nine Lakh Ninety Thousand Only) , subject to the condition that the Director, Scheduled Tribes Development Department shall assess the age and structural condition (fitness) of the building and ensure that the

maintenance expenditure is economically justified.
