(2) The State Level Working Group held on 22/12/2025 considered the proposal and recommended approval of the same ,subject to the condition that the Director, Scheduled Tribes Development Department shall assess the age and structural condition (fitness) of the building and ensure that the maintenance expenditure is economically justified.
