### ORDER

The Director, Scheduled Tribes Development Department as per the letter read above has submitted a project proposal for Construction of Skill Park at AMRID, Kalpetta, Wayanad district at an estimated cost of an amount of Rs.2,00,00,000/- (Rupees Two Crore Only) to Government for placing before the State Level Working Group Committee.

(2) The State Level Working Group held on 22/12/2025 considered the proposal and recommended approval of the same , subject to the condition that the construction component of the project to be assigned to District Nirmithi kendra, Wayanad and the Procurement of Machineries & Equipments for skill training shall be done by AMRID following Store Purchase Manual norms.

(3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for the project proposal for **Construction of Skill Park at AMRID, Kalpetta**, Wayanad district at an estimated cost of an amount of **Rs.2,00,00,000/-** (Rupees Two Crore Only) , subject to the condition

that the construction component of the project to be assigned to District Nirmithi kendra, Wayanad and the Procurement of Machineries & Equipments for skill training shall be done by AMRID, following Store Purchase Manual norms.
