## <u>ORDER</u>

As per the Government Order read as 1 <sup>st</sup> paper above, Administrative Sanction was accorded to the Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd, for Skill & Entrepreneurial Development Programme (2024-25) at an estimated cost of Rs.300 lakh meeting the expenditure from the head of account '2235-02-190-97-34-OC(Plan)' provided in the current year's budget
