ORDER

As per Government order read as 1st paper above, 39 cents of land in Resurvey No.61/2A2 in Beypur desam, Kozhikode district was assigned to the Indian Coast Guard by realizing an amount, not less than Rs.51.14 lakhs, for the construction of slipway & jetty, in exercise of the special powers vested in the Government under Rule 21(ii) of the Assignment of Land within Municipal & Corporation Areas Rules, 1995.

2. As per letter read as 2nd paper above, the Coast Guard Commanding Officer submitted application to the Kozhikode District Collector to assign the land to them either by completely waiving off the amount fixed by the Government or by charging only a nominal amount.

- 3. Considering that the Indian Coast Guard is a security force under the Government of India and that the said land will help in strengthening maritime security of the Malabar coast, the Land Revenue Commissioner, as per letter read as 4th paper above, has recommended to assign the land either by completely waiving off the assignment value or by charging a nominal amount.
- 4. The Director, Coast Guard has informed in the meeting held by the Chief Secretary, minutes of which is read as 5th paper above, that they are ready to pay the current fair value of the land.
- 5. Government have examined the matter in detail. Considering this as a matter of public interest as Indian Coast Guard is the main security agency for securing the Indian Coast, Government are pleased to amend GO.(MS)No.11/2020/RD dated 04/01/2020 by assigning 39 cents of land in resurvey 61/2A2 in Beypur desam, Kozhikode to Indian Coast Guard by levying only the current fair value of the said land.
- 6.The District Collector, Kozhikode shall take necessary action in this regard.
