Hence the Director has also requested to release an amount of ₹75,00,000/- (Rupees Seventy-five Lakh Only) as first installment of Administrative Expenses to the PSTSB A/c No. 799012700001171 of District Treasury, Kozhikode.

sanction for the release of ₹25,00,000/- (Rupees Twenty-five Lakh Only), from the Head of Account: 2235-02-103-80-35-P(V), towards the first installment of administrative expenses of the Gender Park during 2025-2026 and to credit the same to the PSTSB A/c No.799012700001171 of the Gender Park, maintained by the District Treasury, Kozhikode.
