### <u>ORDER</u>

As per the G.O read as 1<sup>st</sup> paper above, Government have accorded Administrative Sanction for the "Strengthening and upgradation of State Medical Colleges for increase in PG seats - Phase II at Government Medical College, Kannur. As per the G.O read as 2<sup>nd</sup> paper above, Government had sanctioned an amount of Rs. 1,38,02,000/as corresponding State Share under the above scheme. As per the G.O read as 3<sup>rd</sup> paper above, Government had accorded Administrative Sanction to utilise the fund for the CSS project "Strengthening and upgradation of State Medical Colleges for increase in PG seats" at GMC Kannur. As per the letter read as 5<sup>th</sup> paper above, the Director of Medical Education has forwarded a proposal for permitting to use the surplus fund of Rs.64,600/- from the purchase of 'Digital Spectrophotometer', for meeting the additionally required amount of Rs.25,440/- for the purchase of 'Office Hysteroscope'.

2) Government have examined the matter in detail and are pleased to accord permission to the Director of Medical Education to utilise the additional amount of Rs.25,440/- required for the purchase of 'Office Hysteroscope' worth Rs.1,25,440/-, from the surplus money from the purchase of equipment 'Spectrophotometer', subject to the condition that the total expenditure of the project shall not exceed original AS amount of Rs.2,23,25,000/- for which permission had been accorded to utilise the fund for the CSS project "Strengthening and up-gradation of State Medical Colleges for increase in PG seats" at GMC Kannur.
