ORDER

Accordingly, work order has been issued to M/s Habitat Technology Group by the Additional Director General Police (Intelligence) and Payment upto the final part bills were made for a total amount of Rs. 7,92,19,840/-.

- 2) From the final bill, an amount of Rs, 8,90,000/- was temporarily deducted due to the non completion of fire sump work on condition that this amount will be made only after submitting completion report for the above works and getting it verified and recommended by the joint check measurement committee.
- 3) The State Police Chief vide the letter read above has reported that as per the report of the ADGP (Intelligence) the rectification work of fire sump installed at SSB HQ done by M/s Habitat Technology Group, verified by the Verification Committee on 18.05.2024 and reported that there is no leakage

of water at pump room and recommended for the release of payment of Rs 8,90,000/- towards the Construction of fire Sump and State Special Branch has no objection to release the payment towards the Fire Sump installed at SSB Head Quarters. Therefore the State Police Chief has requested to allot the fund for the above construction work to the tune of Rs.8,90,000/-for clearing the final payment to the construction agency.

4) Government after having examined the matter in detail are pleased to accord sanction to release the amount of Rs.8,90,000/- (Rupees Eight Lakhs Ninety Thousand Only) under the head of account 4055-00-207-92-00-P-V for clearing the final payment to the construction agency towards the rectification work of fire sump installed at State Special Branch Head Quarters.
