ORDER

The seniority list of the combined cadre of Circle Inspector/Managers/Superintendents of Excise for the period from 01.01.2009 to 01.06.2019 has been recast and published as per the reference read as 1st paper above. The Ad hoc Departmental Promotion Committee (Higher) of Excise Department, which met on 28.11.2024, has revised the select list of Excise Circle Inspector for promotion to the cadre of Assistant Commissioner of Excise for the year 2021 and also prepared the select lists for the years 2022, 2023 and 2024. The select list so prepared has been published as per reference read as 4th paper above. Consequently, it has become necessary to re assign the promotion dates of Assistant Excise Commissioners in accordance with the revised select lists.

2. Out of the 35 incumbents shown in the table below Para 3, the officers from Sl No 1 to Sl No 22 have been granted regular
