ORDER

Government have accorded administrative sanction to engage Advocate Samim Ahammed, 6/1, Ahiripukur, 2nd Lane Beck Bagan, Kolkata-700019 as Counsel to represent the State in the filing of Writ Petition before the Hon'ble High Court of Calcutta, challenging the order of the WBMSE Facilitation Council as per Government order read as 2nd paper above. Also as per Government order read as 3rd paper above, sanction was accorded for an amount of Rs.4,95,150/- towards the payment of Memo of fees including the Professional fee of the Senior Counsel.

2) Now the State Police Chief as per letter read above, has informed that Adv. Samim Ahammed has submitted the Memo fees for the period from 12.02.2025 to 27.11.2025, including the professional fees of the senior counsel for a total amount of Rs.7,27,650/- for payment and it is also informed that the Advocate General has recommended the said fee claimed by the Learned Counsel. Therefore the State Police Chief has requested to accord administrative sanction for the said amount along

with fund for making payment to Adv. Samim Ahammed under the Head of Account 2055-00-001-99-00-28- payment.

3) Government have examined the matter in detail and are pleased to accord administrative sanction for an amount of Rs.7,27,650/- (Rupees Seven Lakhs Twenty Seven Thousand Six Hundred and Fifty Only) under the head of account 2055-00-001-99-00-28 towards the payment of Memo of fees including the Professional fee of the Senior Counsel Adv. Samim Ahammed, for appearing on behalf of the Government of Kerala in the Hon'ble High Court of Culcutta in WPA 20486/2024, as recommended by the Advocate General.

4) The said amount has been additionally authorised as per Government Order read as 5th paper above.
