ORDER

As per GO read as Ist paper above, Administrative Sanction was accorded for an amount of Rs. 15 Cr. to Central Institute of Plastic Engineering and Technology (CIPET), Kochi for implementing "Vertical Expansion of building and up-gradation with Advanced machinery at CIPET Kochi" under the scheme "Development of Industrial Parks/ areas/ estates on PPP mode". As per G.O read as 2nd and 3rd above, Government had accorded sanction to release an amount of Rs10 Crore for the scheme.

2. As per letters read as 5th paper above, Director of Industries and Commerce, has requested for the reclassification of the aforesaid expenditure incurred in the previous years (involves capital heads in both sides) which causes an alteration in opening and closing balances under different heads of account in Finance accounts, a token provision in Supplementary Demands for Grants is also necessary to carry out the adjustments through proforma correction and Sanction is required for

carrying out accounting adjustment in accounts.

3. Government have examined the matter in detail and are pleased to accord sanction for carrying out the reclassification of expenditure of Central Institute of Plastic Engineering and Technology (CIPET) for an amount of Rs.10 Cr (Ten Crore) incurred in the previous years under the head of account '4851-00-101-87-00-00 PV - Development of Industrial Parks/ Areas/ Estate on PPP Mode' to the head of account '4885-60-800-92-00-00 PV - Centre for Bio Polymer Science and Technology-Investment' through proforma correction by the Accountant General as detailed below.
