## **ORDER**

Therefore the State Police Chief has requested to accord administrative sanction for purchasing the furniture for the newly constructed Tele & Tech office building, Palakkad for an amount of Rs.2,10,302/- under the head of account 2055-00-114-99-00-05-04-N-V, considering the urgent necessity of the items.

2) Government have examined the matter in detail and are pleased to accord administrative sanction for the purchase of furniture limiting the

3) The items having rate contract only shall be purchased directly from SIDCO, otherwise guidelines in Stores Purchase Manual shall be followed.
