2) Government have examined the matter in detail and are pleased to release an amount of Rs.166,66,66,667/- (Rupees One Hundred and Sixty Six Crores Sixty Six Lakhs Sixty Six Thousand Six Hundred and Sixty Seven only) (including Central share of an amount of Rs.100,00,00,000/- under the H/a "2210-06-101-19-01" and State share of an amount of Rs.66,66,66,667/- under the H/a "2210-06-101-19-02") to National Health Mission.
