ORDER

As per the letters read as papers 1 st above, Ministry of Tribal Affairs (MoTA) has released a total amount of Rs. 3,03,13,000/- (Rupees Three Crore Three lakh and Thirteen Thousand only) in the form of **Mother Sanction** towards the Grant-in-aid-General & CCA under Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (**DA JGUA**) during the year 2026-27 for the purpose of carrying out activities as approved by the PAC meetings held on 24/12/2024,07/11/2024,08/04/2025 & 01/05/2025 which are noted in the table below. Amount released towards Grant- in-aid General is Rs. 1,05,05,000 (Rupees One Crore five lakh five thousand only) and that towards CCA is Rs. 1,98,08,000 (Rupees One Crore ninety eight lakh eight thousand only). [Total amount is Rs. 3,03,13,000/- (Rupees Three Crore Three Lakh and Thirteen Thousand only)].

Accordingly, The Director of Scheduled Tribes Development Department, as per the letter read as 2nd paper above, has requested to

accord Administrative Sanction for implementing the projects/activities, which are approved by MoTA, utilizing the total released amount of Rs. 3,03,13,000/- (Rupees Three Crore Three lakh and Thirteen Thousand only), from the respective Heads of Account, as noted below:
