Government had released an amount of Rs.725 lakhs, sanctioned for various programmes under Ongoing Schemes to the PSTSB A/c No. 512 with the District Treasury, Thiruvananthapuram as per the G.O. read as 6th paper above. From which Cheque was not cleared by the Treasury as on 31.03.2025 and an amount of Rs.715 Lakhs was resumed by the Govt. Managing Director, Kerala State Women's Development Corporation has requested to reimburse an amount of Rs. 715 Lakhs, that were resumed under the h/a: 2235-02-190-99 to KSWDC.

An amount of Rs.13 Lakhs was released as first installment to **PSTSB** with the a/c No.512 the District Treasury, Thiruvananthapuram as per G.O. read as 2^{n d} paper above. Government had released an amount of Rs.22 Lakhs as per G.O. read as 5th paper above, for which cheque was not cleared by the Treasury. On 31.03.2024 an amount of Rs.22 Lakhs was resumed by the Government. As on 31.03.2025, an amount of Rs.55.07 Lakhs have been incurred for meeting the expenditure of various projects under this scheme. Out of the total expenditure of Rs. 55.07 lakhs, Rs. 33 lakhs were utilized from the fund released by Government. The balance amount of Rs. 22.07 Lakhs were utilized from the other fund sources of the Corporation that needs to be recouped. Managing Director, Kerala State Women's Development Corporation has requested to reimburse an amount of Rs. 22.07 Lakhs, that were resumed under the h/a:(2235-02-103-90 (02)) to KSWDC.

An amount of Rs.80 Lakhs was released as first installment to the PSTSB a/c No.512 with he District Treasury, Thiruvananthapuram as per G.O. read as 4th paper above, for which cheque was not cleared by the Treasury. On 31.03.2025 an amount of Rs.80 Lakhs was resumed. As on 31.03.2025, an amount of Rs.86.72 Lakhs have been incurred for meeting the expenditure of various projects under this scheme. Out of the total expenditure of Rs. 86.72 lakhs, Rs. 20 lakhs were utilized from the fund releases by Government. The balance amount of Rs.66.72 Lakhs were utilized from the other fund sources of the Corporation that needs to be recouped. Managing Director, Kerala

State Women's Development Corporation has requested to reimburse an amount of Rs. 80 Lakhs, that were resumed under the h/a: 2235-02-103-89 to KSWDC.

4) In light of the above, Managing Director, Kerala State Women's Development Corporation as per the letter read as 7th paper has requested to reimburse the funds that were resumed an amount of Rs.715 lakhs under the h/a:2235-02-190-99 for the implementation of Ongoing Schemes, an amount of Rs. 22 Lakhs, that were resumed under the h/a:(2235-02-103-90 (02)) for various programmes under Flagship Program on Gender Awareness and an amount of Rs. 80 Lakhs, that were resumed under the h/a: 2235-02-103-89 for various programmes under Programme on Finishing School. MD, KSWDC has also requested to reallocate an amount of Rs.8,17,00,000/- (Rs.Eight Crore and Seventeen Lakhs Only) against the funds resumed by the Government from the PSTSB A/c No. 799012700000512 with the District Treasury, Thiruvananthapuram at the end of the financial year 2024-25.
