### ORDER

As per G.O.s read paper 2<sup>nd</sup> and 3<sup>rd</sup> above, Government of Kerala engaged with World Bank, AIIB and AFD for the Resilient Kerala Program (RKP) Program for Results (PforR) (2021-26) and with the World Bank for the RKP Additional Financing (2023-28).

2. As part of the above engagements, the Water Resources Department, in consultation with the World Bank, identified certain interventions among the 30 interventions targeted in Year 3 of Disbursement Linked Indicator (DLI) 7, which are categorized as '*Must Do Works*'. These works represent the works with 'obvious need of implementation' based on a 'stop-the-hazard' approach.

3. The Chief Engineer, Irrigation & Administration, as per letter read 4<sup>th</sup> paper above, furnished proposals/DPRs of four '*Must Do Works*' with a total estimated cost of ₹1.61 crore, and requested sanction for the same. The list/details of the works are summarised below;

1.	Rejuvenation of Pampa River restoration of the left bank of Pampa River d/s of Elamkavilkadavu near MSTTI in Ranni Panchayath	0.4500
2.	Restoration of eroded embankment on the left bank of Achenkovil river near KWA pump house near Kottarathil kadavubhagam in ward no. 11 of Konni panchayat in Konni constituency	0.2190
3.	Restoration of eroded embankment on the left bank of Achenkovil river and urgent stabilization of footbridge near Valachuzhy temple in Pramadam Panchayath.	0.3918
4.	Urgent removal of deposited silt and debris from the periphery of water authority intake well to ensure sufficient water collection and rectification of the Kadavu and protection wall in Ranni Angadi Panchayat of Ranni Constituency.	0.5500

4. The RKI Implementation Committee (IC) meeting held on 03-07-2024, the minutes of which is read as paper 5<sup>th</sup> above, considered the above matter and approved the four *Must Do Works*, at an estimated cost of ₹1.61 crore.

5. The Government after having examined the matter in detail, are pleased to issue sanction to the four *Must Do Works* proposed by the Water Resource Department, as detailed in *para 3* above, at an estimated cost of **₹1.61 crore (Rupees One crore and Sixty-one lakh only)**. The expenditure in this regard shall be debited to the H/A 5475-00-115-94-Post flood Projects under Rebuild Kerala Initiative (P).

6. All procurement as part of implementation of the works shall be done in a fair and transparent manner, in accordance with the extant rules and all mandatory clearances from relevant departments shall be obtained wherever applicable.
