ORDER

As per the Order read as 1st paper above, relocation of 438 families from private settlements within the forest areas of Kannur, South Wayanad Mannarkkad and Thiruvananthapuram Forest Divisions at a cost of Rs.6570 lakh, was approved under the KIIFB Project FOR001-00 "Fencing along Forest Boundary under the Special investment Plan" Phase-II. As 63 families in Melekalam settlement are not willing to move out and all the eligible 126 families of Dallikkarikkam Settlement in Kulathupuzha Village was willing to be relocated, Government issued orders excluding Melekalam settlement in Mannarkkad Division and including Dallikkarikkam settlement in Thiruvananthapuram Division in the KIIFB Project FOR001-00 "Fencing along Forest Boundary under the Special investment Plan" Phase-II as per the Order read as 2nd paper above. Accordingly, the total number of willing eligible families to be relocated increased from 438 to 501 and the estimated expenditure also increased from Rs.6570.00 lakh to Rs.7515.00 lakh.

As per the letter read as 4th paper above, the Additional Principal Chief Conservator of Forests (F, B&A) & Special officer, RKDP-PMU has informed that, KIIFB has intimated that it may not be possible for them to include Dallikkarikkam under relocation component of KIIFB due to shortage of funds. It has been informed that, an estimated 88 willing eligible families of Dallikkarikkam settlement require Rs.13.20 crore @Rs. 15 lakh per eligible family. The matter was placed before the 4th SLEC meeting and the SLEC

approved the proposal to include Dallikkarikkam settlement in Thiruvananthapuram Division under RKDP. The Additional Principal Chief Conservator of Forests (F, B&A) & Special officer, RKDP-PMU has therefore requested to issue orders including the Dallikkarikkam settlement under Rebuild Kerala Development Programme (RKDP).

3. Government have examined the matter in detail and are pleased to exclude Dallikkarikkam settlement in Thiruvananthapuram Division from KIIFB Project FOR001-00 "Fencing along Forest Boundary under the Special investment Plan" Phase-II and include Dallikkarikkam settlement in Thiruvananthapuram Division under Rebuild Kerala Development Programme (RKDP) as tabled below.
