ORDER

In the State Budget for the financial year 2025-26, an amount of Rs.300 Lakh has been provided to Health Services Department, for implementation of the Plan Scheme - 'Solid and Liquid Waste Management in all Government Hospitals' under the head of account '2210-01-110-08 (P)'. As per the decision of DWG meeting held on 19.06.2025. vide Government Order read above. Administrative Sanction was accorded for the work - Sewage Treatment Plant at Taluk Head Quarters Hospital, Harippad to the tune of Rs.1,03,61,000/- under the head of account '2210-01-110-08 (P)'. Permission was also granted for carrying out the work through the Muncipality, Harippad, by utilising the available plan fund amount of Rs.48,34,012/- which was already deposited with the Muncipality during 2014. Sanction was also accorded to meet the required balance fund amounting to Rs.53,61,000/- from the Plan fund provision under the head of account '2210-01-110-08 (P)' for the financial year 2025-26,

2. As per the letter read above, the Director of Health Services has requested to cancel the aforementioned Revised Administrative

Sanction accorded for the work - Sewage Treatment Plant at Taluk Head Quarters Hospital, Harippad since the Muncipality has agreed to carryout the works with their own funds and requested to accord Administrative Sanction for a new work - Sewage Treatment Plant at THQH, Mangalppady, Kasaragod.

- **3.** The Departmental Working Group meeting held on 29.10.2025 examined the aforementioned proposal furnished by the Director of Health Services and decided to approve the same, as detailed in the minutes read above.
- 4. Government have examined the matter in detail. Accordingly, in pursuance to the decision of the Departmental Working Group meeting, Administrative Sanction is hereby accorded for the work -Sewage Treatment Plant at THQH Mangalppady, Kasaragod for an amount of Rs.2,70,80,000/- (Rupees Two Crore Seventy Lakh and Eighty Thousand Only) under the plan scheme 'Solid and Liquid Waste Management in all Government Hospitals', by meeting the expenditure under the head of account '2210-01-110-08 (P)'.
- **5.** All purchases shall be made in strict observance of Stores Purchase Rules. The work shall be done in a transparent manner and in accordance with the approved proposal, prevailing norms and conditions.
