ORDER

The Chief Engineer, Harbour Engineering Department, as per the letter read above has submitted a proposal for the 'Improvements of Aduka Hulasinadi - Aduka Valak Road of Manjeswaram Constituency in Kasargode District' for a total outlay of Rs. 50 lakh, under the H/A 4405-00-103-94-NP, as included in the Budget Estimate 2024-25 Appendix II(Sl.No.05, Budget No. 942) and has requested to accord Administrative Sanction for the same.

(2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the 20% work "Improvements of Aduka Hulasinadi - Aduka valak road in ward No. 12 of Mangalpady panchayat in Kasaragod-Adka-olack road-General Civil Works Kasaragod district" for an amount of Rs. 50 lakhs under the H/A 4405-00-103-94-00-00-0-N-V, subject to the following conditions:

1. The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.
2. The Technical Sanction Authority has to regulate the provision for shoulder

concrete/ berm concrete/ irish drain, etc. for shoulder protection in gradients/curves at essential locations and for a maximum width of 50 CM.

3. The soil report and structural design of the retaining wall have not been submitted along with this estimate. Therefore, the Technical Sanction authority shall ensure the structural stability of the retaining wall, taking economy into consideration.
