### ORDER

Whereas, the Government are of opinion that an industrial dispute exists between Smt.Sumayya Sulaiman, Proprietor, Fashion Plus, Near Kerala Gramin Bank, Main Road, Wadakkanchery, Thrissur - 680 582 (Address- Smt.Sumayya Sulaiman, D/o Sulaiman, Kambran Veedu, Vengara P.O, Malappuram - 676 305) and the workman of the above referred establishment Smt.Gilna W/o Andrews Varghese, Athikkottil Veedu, Kundanoore P.O, Wadakkanchery - 680 590 in respect of matters mentioned in the annexure to this order;

And whereas, in the opinion of Government it is necessary to refer the said industrial dispute for adjudication;

Now, therefore, in exercise of the powers conferred by Section 10(1) (c) of the Industrial Disputes Act of 1947 (Central Act XIV of 1947) the Government hereby direct that the said industrial dispute be referred for adjudication to the Labour Court, Ernakulam. The Labour Court will pass the award within a period of three months.
