ORDER

As per the representation submitted by M/s WIPL read as first paper above and the decision taken in the meeting held on 26.10.2023 read as second paper above, Government have accorded administrative sanction, vide Government order read as 3rd paper above for the allotment of 50,000 MT of pulpwood to M/s. Western India Plywoods Limited (M/s.WIPL) during the financial year 2025-2026. As per the order dated 4th above, Government have accorded sanction to execute the agreement between Kerala Forest Department and M/s.WIPL during the financial year 2025-2026.

2) As per the letter read as 5th paper above, Principal Chief Conservator of Forests (Forest Management) has submitted the draft agreement to be executed between Kerala Forest Department and M/s. WIPL for governing the extraction process of Senna during the financial year 2025-2026.

3) Government have examined the matter in detail and are pleased to accord sanction to the Principal Chief Conservator of Forests (Forest Management) to authorise Divisional Forest Officer, North Wayanad Forest Division, Mananthawady to execute the agreement between Kerala Forest Department and M/s. WIPL for the allotment of Senna to M/s. Western India Plywoods Limited (M/s. WIPL) during the financial year 2025-2026. The draft agreement in this regard to be executed between Kerala Forest Department and M/s. WIPL, which is appended herewith, is also approved subject to the addition/inclusion of following clauses in the agreement.

- i. The date, month, year, and place of execution shall be clearly mentioned in both the introductory clause and the effective clause of the draft agreement.
- ii. The Government orders, Proceedings, communication, minutes of the meetings etc mentioned in the draft agreement shall be verified entered correctly and kept as annexure to it.
- iii. The name, designation, and official address of the authorised signatories of both parties shall be uniformly stated in the introductory clause and the execution clause of the agreement based on this Government Order.
- iv. The particulars of this order permitting execution of agreement shall be included as a preliminary clause in the last paragraph of the agreement and shall be annexed to it.
