(2)An initial concept note needs to be prepared to apply for funding support under these schemes which will involve site visits, data collection, preliminary surveys and technical expertise requiring assistance from specialized agencies. In view of this, The Director of Tourism as per letter read as 1st paper above, had submitted proposals to the tune of ₹3,00,00,000/- (Rupees Three Crore) for Preparing Concept Notes, Inception Reports and DPRs for various tourism projects under the Central Sector Schemes.
