ORDER

Sanction was accorded to all Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies, etc., to effect direct purchase of textile goods required by them from M/s. Hanveev without resorting to tender formalities, as per the Government Order read as the 1st paper above. Subsequently, the period of validity of the aforesaid relaxation was extended by the Government from time to time, and the last extension was issued vide the Government Order read as the 2nd paper above.

2. As per the letter read as the 3rd paper above, the Managing Director, M/s. Hanveev, has requested the Government to extend the period of validity of the aforesaid relaxation with effect from 07.11.2025, as the same expired on 06.11.2025.

3. The Government have examined the matter in detail and are pleased to accord sanction for relaxation from the provisions of Para 9.23 of the Revised Stores Purchase Manual for a period of six months with effect from the date of issuance of this order, to enable M/s. Kerala State Handloom Development Corporation Ltd. (Hanveev) to supply textile goods, without exceeding the general market price, to Government Departments, Public Sector Undertakings, Local Self Government Institutions, Autonomous Bodies, etc., without resorting to tender formalities, subject to the following conditions :-

(i) Hanveev shall submit the quality certificate for the products, issued by the

Industries Department, along with a comparative report of market prices provided by the Department of Economics and Statistics and an item-wise price list of the products, duly certified by a cost accountant, within three months from the date of issue of this order.

(ii) Marketing on the basis of this exemption shall not be permitted after the expiry of the validity period.
