ORDER

As per the letter read as 1st paper above, the State Mission Director, National Health Mission has requested to allot an amount of Rs.41,66,66,667/- (Rupees Forty One Crore Sixty Six Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) (Rs.25,00,00,000/- Central share and Rs.16,66,66,667/- State share) for PMABHIM by re appropriating an amount of Rs.16,66,66,667/- from 2210-06-101-09-01(PV) to concerned heads in line with the GoI release in SNA SPARSH mode for the implementation of programmes approved by Government of India for 2026-27.

2) As per the G.O read as 2nd paper above, Government have opened a new Head of Account "2210-06-789-96-(01)(02)" and "2210-

06-789-92-(01)(02)" for the above purpose. As per the G.O read as 3rd paper above, Government have re appropriated an amount of Rs.16,66,68,000/- from the HoA "2210-06-101-09-01" to the HoA "2210-06-101-09-02" (Rs.11,29,02,000/-); "2210-06-789-96-02" (Rs.4,59,62,000/-); "2210-06-796-92-02" (Rs.78,04,000/-) for meeting the expenditure in connection with the NHM projects.

3) Government have examined the matter in detail and are pleased to release an amount of Rs.41,66,66,667/- (Rupees Forty One Crore Sixty Six Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) (Central share amount of Rs.25,00,00,000/-and its corresponding state share amount of Rs.16,66,66,667/-) for PM-ABHIM under SNA SPARSH platform in the General, SCP and TSP component as detailed below;
