ORDER

As a part of the Annual Plan 2026-27, Government have provided an outlay of ₹1000.00 lakh under the scheme "KSIDC Industrial Parks" for undertaking infrastructure development works in industrial parks initiated by Kerala State Industrial Development Corporation Ltd. (KSIDC). The scheme envisages land development, building renovation, completion of existing infrastructure works, to prepare master plan and maintenance of common infrastructure facilities in Industrial Park, Kuttiyadi, KSIDC Investment Zone, Palakkad, Mega Food Park, Cherthala and General Industrial Park, Cherthala, so as to facilitate industrial and economic development in the State.

2. Aims and Objectives

The scheme aims to strengthen industrial infrastructure across KSIDC Industrial Parks by creating and upgrading common facilities including roads, drainage, water supply, power infrastructure, industrial utilities, common effluent treatment facilities, security infrastructure and other common amenities. The scheme is intended to facilitate industrial investment, economic development, industrial competitiveness, employment

3.The Managing Director, Kerala State Industrial Development Corporation Ltd., as per the letter read above, has submitted the proposal for implementation of the scheme "KSIDC Industrial Parks" during the financial year 2026-27 and requested Government to accord Administrative Sanction for an amount of ₹10,00,00,000/- (Rupees Ten Crore only). The proposal was placed before the Departmental Working Group held on 08.07.2026 and recommended to issue Administrative Sanction limited to the budgetary provision.

4) Government have examined the matter in detail and are pleased to accord Administrative Sanction for an amount of ₹10,00,00,000/- (Rupees Ten Crore Fifty only) for the the Project " KSIDC Industrial Parks" under the head of account 4885-01-200-95(PV) subject to the following conditions:

- All rules, formalities and procedures in force shall be strictly followed for the implementation of the project.
- Expenditure would be met only from the provision available under appropriate head of account.
- Release of funds will be based on actual requirements and the funds released should not be parked in banks.
- Stores Purchase Rules shall be strictly adhered to wherever applicable.
- Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- Post creation and purchase of vehicles are not admissible under the scheme.

4) The Managing Director, KSIDC will ensure that the development and improvement works of all the above Industrial Parks is completed in time and in the manner as envisaged in the original proposal.
