ORDER

The scheme envisages strengthening industrial infrastructure at the Industrial Growth Centres at Cherthala, Kannur and Kozhikode through development of roads, drainage, water supply systems, electrical infrastructure, surveillance systems, fire safety measures, renovation of existing buildings and other common infrastructure required for industrial development.

2. Aims and Objectives

The objective of the scheme is to strengthen industrial infrastructure in KSIDC Industrial Growth Centres by providing quality common facilities, facilitating establishment of new industrial units, improving infrastructure for existing units, enhancing safety and environmental standards, and creating an investor-friendly industrial ecosystem that promotes industrial growth, investment and employment generation in the State.

3.As per letter read as first paper above, the Managing Director, KSIDC has submitted a proposal to Government seeking Administrative Sanction for the implementation of the project 'KSIDC Industrial Growth Centres' at a total estimated cost of ₹1068 Lakhs (Rupees Ten crore and sixty-eight lakhs only) by meeting the expenditure limiting to the current year's budget provision under the Head of Account 4885-01-200-95 (P).

4. Annual Plan proposal submitted by the MD, KSIDC was considered by the First Departmental Working Group meeting held on 08.07.2026 and recommended to issue Administrative Sanction limited to the budgetary provision.

5. Government have examined the matter in detail and are pleased to accord Administrative Sanction for an amount of ₹1068 Lakhs (Rupees Ten crore and sixty-eight lakhs only) for the Project " KSIDC Industrial Growth Centres" under the head of account 4885-01-200-95 (p), subject to the following conditions:

- All rules, formalities and procedures in force shall be strictly followed for the implementation of the project.
- Expenditure would be met only from the provision available under appropriate head of account.
- Release of funds will be based on actual requirements and the funds released should not be parked in banks.
- Stores Purchase Rules shall be strictly adhered to wherever applicable.
- Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- Post creation and purchase of vehicles are not admissible under the scheme.

6) The Managing Director, KSIDC will ensure that the development and improvement works of all the above industrial Growth Centres is completed in time and in the manner as envisaged in the original proposal.
