### ORDER

As per letter read as 3rd paper above, Director of Agriculture had submitted a proposal prepared by the Principal Agricultural Officer, Wayanad for the revival of agricultural sector in the Mundakkai-Chooralmala landslide-affected area in Wayanad District, at an estimated cost of ₹340 lakhs (Rupees Three Crore Forty Lakhs only). The proposal intends to support farmers affected by the landslide through comprehensive interventions including soil and land reclamation, crop insurance, formation of Farmer Producer Organisations (FPOs), skill development, restoration of cultivation infrastructure and replanting initiatives in the affected Panchayats.

2)As per G.O read as 1st paper above, assistance in the agriculture sector is admissible for land and crop loss, de-silting, removal of debris etc.

3)As per G.O read as 2nd paper above ,Government had sanctioned an amount of Rs.3,78,110/- from SDRF to the District Collector, Wayanad towards immediate relief measures for the farmers who lost their agricultural land in the Wayanad landslide.

4) Government have examined the matter in detail and are pleased to

accord Administrative Sanction for the implementation of the proposal ' Revival in Agricultural Sector for Mundakkai-Chooralmala landslide affected area' for an amount of ₹340 lakh ( Rupees Three Crore Forty Lakhs only) for compensating the agricultural losses caused by the Chooralmala landslide disaster in Wayanad.

The said amount shall be released from the untied ₹120 crore, available in SDRF under the H/A 2245-02-101-94 Flood Other Items which can be utilized in relaxation of SDRF norms to the following TSB Account of Principal Agricultural Officer Wayanad.
