ORDER

Technical Sanction Committee for according Technical Sanction for the works under Health Department was constituted as per G.O read as 2nd paper above with the Chief Engineers of the PWD Buildings, Electrical and Mechanical Wings . Accordingly the works under Health Department are being scrutinized and approved by the said Committee. However, frequent delay is seen occurred in the technical sanction process due to the delay in getting the estimates vetted by the members of the Committee. The Chief Engineers of the different wings of PWD are already heavily engaged in their departmental responsibilities. The additional duty of vetting estimates of works entrusted to accredited agencies significantly burdens them, contributing to delays in the vetting process. Earlier, the Chief Engineer (Buildings), PWD vide letter read as 5th above, had highlighted this issue and requested exemption from the Technical Sanction Committee, citing the Circular mentioned as the 4th paper above.


