ORDER

As per the Government Order read as 1st paper above, an amount of Rs.47.90 Crore (Rupees Forty Seven Crores Ninety Lakh only) (Central share of Rs.28.74 Crore and State Share of Rs.19.16 Crore) has been released under the Head of Account "2210-06-101-19-02 (PV), to the State Mission Director, National Health Mission as a part of 1st

installment of mother sanction for the implementation of programmes approved by GOI for the year 2025-26. As per the G.O read as 2nd paper above 2nd installment of mother sanction for an amount of Rs.115,55,00,000/- (Rupees One Hundred and Fifteen Crore and Fifty Five Lakh only) has been released to NHM.

2) As per the letter read as 3rd paper above, the Government of India has released third mother sanction for an amount of Rs.40,00,00,000/- as grant -in- aid for Flexible pool for RCH and Health System Strengthening, National Health Mission programmes and Urban Health Mission under NHM for 2025-26. As per the letter read as 4th paper above, the NHM has requested to allot an **amount of Rs.66,66,66,667/-** (Rupees Sixty Six Crore Sixty Six Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) including an amount of Rs.40,00,00,000/- as Central Share and Rs.26,66,66,667/- as State Share, in SNA SPARSH mode under the HoA "2210-06-101-19-02 (PV)" by way of reappropriation from "2210-06-101-19-01-(PV)".

3) As per the G.O read as 5th paper above, an amount of Rs.40,21,67,000/- has been sanctioned through reappropriation from the HoA "2210-06-101-19-01-(PV)" to the HoA "2210-06-101-19-02 (PV)".

4) Government have examined the matter in detail and are pleased to release the third installment of mother sanction for an amount of **Rs.66,66,66,667/- (Rupees Sixty Six Crore Sixty Six Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) (Central share of Rs.40,00,00,000/- and State Share of Rs.26,66,66,667/-)** from the HoA "2210-06-101-19-02-NHM (P) (V)" utilising the balance amount of Rs.26.45 Crore available under the HoA provided through SDG and

Rs.40.2167 crore sanctioned vide the G.O read as 5th paper above, to NHM for the implementation of programmes approved by Government of India for 2025-26.

5) The State Mission Director, National Health Mission shall take timely steps to furnish Utilisation Certificate to Government.
