ORDER

An amount of ₹ 5.25 lakh was released to the Kerala Rural Water Supply and Sanitation Agency (Jalandhi) from the budget provision of ₹15 lakh under the Head of Account " 2215-01-003-99 (P) Information, Education & Communication (IEC), Capacity Building and Training and Jalasree Club" as per Government Orders read as 1st and 2nd papers above, during the financial year 2025-26.

The Executive Director, Jalandhi, vide letter cited 3rd, has informed that out of the released fund , an amount of ₹4.77 lakh was incurred as expenditure towards the implementation of " Information, Education and Communication, Capacity Building and Training and Jalasree Club Programme" , leaving an unspent amount of ₹48,118/- in the PSTSB Account which was resumed by Government on 31.03.2026. Hence, he has requested to release the resumed fund for the implementation of the remaining components of the scheme.

3. An amount of ₹15 lakh has been earmarked under the Head of Account 2215-01-003-99 (P) for the financial year 2026-27.

4. Government have examined the matter in detail and are pleased to accord sanction for reallocation and release of the resumed amount of ₹48,118/- (Rupees Forty Eight Thousand One Hundred and Eighteen only) from the current year's budget provision under the Head of
