ORDER

The Hon'ble Lok Ayukta in its report read as 1st above, has directed to sanction Terminal Surrender of Earned leave to the Complainant with interest at the rate of 6% per annum on the amount of surrender value of earned leave from 6/7/2017 till the date of payment and has also ordered that the complainant is entitled to Gratuity as admissible to a sitting Judge of the High Court for the qualifying service rendered by him as President of State Consumer Disputes Redressal Commission. The Senior Government Pleader, vide letter read as 2nd above has informed that if Government proposed to file Writ Petition, file the same before the Hon'ble High Court, if

any, to get stay order in the case. Govt vide letter read as 3rd above have requested the Advocate General to take immediate steps to file an appeal against the above order dated 25/3/2024 of the Hon.ble Kerala Lokayukta. It is informed from the Office of the Advocate General, vide reference 4 th above that a competent officer with necessary documents shall reach to the O/o the Advocate General on 11.07.2024 (Thursday) to discuss the matter in order to file an appeal before the Hon'ble High Court against the Lok Ayukta Report.
