ORDER

As per Government order read as 1st paper above, Government accorded sanction for the formation of the KAP VI Battalion with headquarters at Kozhikode. As per the letter read as 3rd paper above, State Police Chief was directed to post Police personnel who are willing to be posted to KAP VI Battalion until the KAP VI Battalion becomes fully operational as per existing rules or depute Police personnel from MSP Battalion on temporary basis.

2)As per letter read as 4th paper above the State Police Chief reported that vacancies arise in KAP VI Battalion due to lack of willing personnel in MSP to move to KAP VIth Battalion. 96

vacancies of Police Constables exist in KAP VI Battalion (71 Men and 24 Women) as on 01-11-2024. Hence, SPC requested to allow Police personal from any battalion including women battalion to be deputed on a temporary basis to KAP VI Battalion. Once they are ripe for promotion or KCP transfer, they may be repatriated to their parent battalion to avail KCP transfer or promotion as the case may be. This would help the Armed Police Battalion to ensure that the KAP VIth Battalion is filled up to its capacity.

3) Government have examined the matter in detail and are pleased to accord sanction to temporarily appoint the willing police personnel from any battalions, including Women Battalion, on deputation basis to the existing vacancies in KAP VI Battalion, strictly by personnel of equal rank and as per rules in force, subject to the condition that the vacancies shall be filled equally from all battalions.
