<u>ORDER</u>

The Director of Factories and Boilers, vide letter read above, has recommended and forwarded the proposal submitted by Shri. Dileep. A, Designated partner and Occupier, Chandra LPG Plant LLP, for their project, to construct LPG Bottling Plant with storage capacity of 3x33 MT of LPG at KSIDC- Industrial Growth Centre, Kuthuparamba, Kannur District, as required under Section 41A of the Factories Act, 1948.

2. Government have examined the matter in detail and are pleased to grant Site Appraisal Clearance to Chandra LPG Plant LLP, KSIDC-Industrial Growth Centre, Kuthuparamba, Kannur District, for the project, to construct LPG Bottling Plant with storage capacity of 3x33 MT of LPG at KSIDC- Industrial Growth Centre, Kuthuparamba, Kannur District, subject to the following conditions as per Section 41A of Factories Act, 1948.

1. The clearance is without prejudice to the stipulations and conditions laid down by other statutory bodies like Pollution Control Board, Petroleum and explosive Department, Town planning Department, Fire & Rescue Department, Science and Technology Department, Environment Department etc.

2. Considering the vulnerability of population of workers in the

upcoming industries and public, mounded LPG storage tanks to be constructed and installed. Management has to compare the collected meteorological data with IMD data. If there is any deviation, revised Quantitative Risk Analysis (QRA) should be conducted and report to be submitted.

3. Relevant applicable national or international natural disaster prevention and mitigation codes to be followed in the design, construction and installation of tanks.

4. On Site Emergency Plan to be revised by marking assembly points and control room considering the meteorological data.

5. All the recommendations in the QRA and HAZOP study reports to be implemented.
