The Project Implementation Committee is authorized to take decisions of the implementation of the Vizhinjam International Seaport project as per the Concession Agreement for the project and to oversee the Land acquisition activities for the project.

- 2. Vizhinjam International Seaport after successful completion of its Phase 1 with an installed capacity of 10 lakh TEU on 03 rd Dec 2024 was dedicated to the nation by the Hon'ble Prime Minister on 02nd May 2025. The port is implementing capacity enhancements to triple its current capacity before 2028 (from 1 million TEUs/annum to 3 million TEUs/annum) and ensuring the completion of last-mile rail connectivity to the port by 2028. Establishing Gateway Traffic will attract Investors for setting up industries near to the Port, especially Industries Importing of raw materials /Export of finished goods at competitive rates. This will enable the Investors to attain world market at competitive rates.
- 3. As per the letter read as 3 rd paper above dated 09-05-2024, the Managing Director, Vizhinjam International Seaport Limited has reported that the 58 th meeting of the Board of Directors of Vizhinjam International Seaport Limited has decided to focus on Port-Led industrialization leveraging the potential of the Port. In order to develop an eco-system for Port Led Industries near to Vizhinjam Port, VISL requires a land bank of a minimum 600 acres land for the commencement of gateway traffic. For the growth of the State of Kerala leveraging the potential of the Port by facilitating Port-led industrialization, the Managing Director, Vizhinjam International Seaport Limited as per the letter read as 3rd paper above dated 23-05-2025 requested sanction to Vizhinjam International Seaport Limited for acquiring 70 to 100 acres of land under LAARA Act, 2013 for developing a Port-Led Industrial cluster in Vizhinjam area in the proximity to the Port and to issue a mandate

authorizing VISL to carry out all the works related to Port - Led Industralization for the socio-economic upliftment of the State.

4. Government have examined the matter in detail. Since the Project Implementation Committee is authorized to take decisions of the implementation of the Vizhinjam International Seaport project as per the Concession Agreement for the project and to oversee the Land acquisition activities for the project, Government are now pleased to extend the mandate of the Project Implementation Committee for all the acquisition of land for project including the Port Led Industrialization in connection with Vizhinjam International Seaport project.
