## <u>ORDER</u>

As per Government Order read as 1<sup>st</sup> paper above, a Special Purpose Vehicle (SPV) namely Malabar International Port & SEZ Ltd (MIPSL) erstwhile 'Azhikkal Port Limited' was constituted for the development of a greenfield port at Azhikkal in Kannur District.

2. As per the letter read as 2<sup>nd</sup> paper above, the M.D. & C.E.O MIPSL reported that the Comptroller & Auditor General of India, in Para-V of their Inspection Report dated 24-10-2024 pointed out that correction is required in Clause 50 the Articles of Association (AoA) of the Company to the extent that the words 'Income and Expenditure account' shall be substituted with 'Statement of Profit and Loss' as stipulated by the Companies Act. The 11<sup>th</sup> Meeting of the Board of Directors resolved to amend the Articles of Association of the Company subject to the approval of the members in their General Meeting by a special resolution. The M.D. & C.E.O.
