### ORDER

As per the Government Order read as 3rd paper above, Government had accorded administrative sanction for the Project Proposal for Enhancement of Inland Fish Production by way of Conservation & Management of Aquatic Resources with a total cost of the project of Rs.400 lakh (Rupees Four Hundred Lakh only) under the Head of Account 2405-00-101-62-34-3(P) from the State budget provision in the financial year 2024-25. The Chief Secretary level committee meeting convened as per the guidelines issued vide GO 1st and 2nd cited for plan prioritization for the year 2024-25, on 05/11/2024, approved the Plan Prioritization proposal in respect of Fisheries Department by limiting the State Plan expenditure of the current financial year to 50% of overall plan outlay of the Department. As per the approved plan prioritization proposal the amount prioritized for the sanctioned project as per GO 3rd cited is 200 lakhs and hence the Director of Fisheries as per the letter read 5th above has requested to issue revised Administrative Sanction accordingly.
