The Chief Secretary level committee meeting convened as per the guidelines issued vide Government Order 1st and 2nd cited for plan prioritization for the year 2024-25, on 05/11/2024, approved the Plan Prioritization proposal in respect of Fisheries Department by limiting the State Plan expenditure of the current financial year to 50% of overall plan outlay of the Department . As per the approved plan prioritization proposal the amount prioritized for the sanctioned project as per Government Order 3rd cited is 300 lakhs and hence the Director of Fisheries as per the letter read 5th above has requested to issue revised Administrative Sanction accordingly.
