**ORDER**

As per the Government Order read above, Government had accorded administrative sanction for the project proposal of Backyard Fish Seed Production for an amount of Rs.493.00 lakh (Rupees Four hundred and ninety three lakh only) under the Head of Account 2405-00-101-87-34-3 (Plan) for the period 2024-25. The Chief Secretary level committee meeting convened as per the guidelines issued vide Government Order 1<sup>st</sup> and 2<sup>nd</sup> cited for plan prioritization for the year 2024-25, on 05/11/2024, approved the Plan Prioritization proposal in respect of Fisheries Department by limiting the State Plan expenditure of the current financial year to 50% of overall plan outlay of the Department . As per the approved plan prioritization proposal the amount prioritized for the sanctioned project as per Government Order 3<sup>rd</sup> cited is 100 lakhs and hence the Director of Fisheries as per the letter read 5<sup>th</sup> above has requested to issue revised Administrative Sanction accordingly.

2) Government have examined the matter in detail and are pleased to accord Revised administrative sanction for the project proposal of Backyard Fish Seed Production with a total cost of the project of Rs.100.00 lakh (Rupees Hundred Lakh only) under the Head of Account 2405-00-101-87-34-3 (Plan) from the State budget provision in current the financial year 2024-25.
