ORDER

An amount of Rs.6.00 Lakh was provided under the Head of Account 4215-01-102-90-P(V) for the implementation of the scheme 'Research & Development in Rural Water Technologies and Management" for the year 2024-25. As per Government Order read as 1st paper above, the estimated cost for the proposed programme is reduced to Rs.3.00 lakh. Subsequently, as per the Government Order read as 2^{n d} paper above, the Administrative Sanction was accorded for the reduced amount of Rs.3.00 lakh.

As per the letter read as 3 rd paper above, the Executive Director, Jalanidhi has reported that the main objective of the scheme is to provide drinking water supply solution using appropriate and innovative technologies and O&M models. He has also stated that in order to implement the scheme and for the timely completion of the programme the amount approved is urgently required and has requested that an amount of Rs.3,00,000/- may be released for meeting the immediate expenses and for the timely completion of the schemes sanctioned.

Government have examined the matter in detail and are pleased to release an amount of Rs.3.00 lakh from current year's budget allocation under the Head of Account 4215-01-102-90-P(V) for the implementation of the scheme "Research & Development in Rural Water Technologies and Management' subject to the following terms and conditions of fund release.

- i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
- ii. The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms)No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Executive Director, Jalanidhi shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO. (Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
