ORDER

As per the GO read first paper above, Government have accorded permissive sanction to KIIFB to finance the rehabilitation of occupants encroached upon lands under the Hill Highway Projects adopting the model of LIFE Mission Scheme. Consequently, KIIFB has sanctioned an amount of Rs. 2,52,00,000/- (Two Crore Fifty-Two Lakh Only) for the rehabilitation of families residing in encroached lands spread across Ottasekharamangalam and Kallikad Grama Panchayat in the Kallikkad-Parassala Hill Highway region.

As per letters read as second and the third papers above, it was requested that the Secretary,Ottasekharamangalam Grama Panchayat may be given permissive sanction to purchase the land and handing over to the beneficiaries for the rehabilitation purpose.

Government have examined this matter in detail and are pleased to entrust the purchase and development of the land, subject to the resolution passed by the Ottasekharamangalam Grama Panchayat

and by abiding the following conditions:

 Only permissible work as per plan guidelines, will be undertaken by the Panchayat in the case of rehabilitation. If the expenses for land development or other amenities emanate for non-permissible components, the additional cost will be met by KIIFB/PWD or other sources.

• If the Panchayat fails to find or purchase suitable land within the available funds, within a timeframe, the Panchayat may intimate the District Collector to initiate action under LARR Act at that level, but can undertake the remaining rehabilitation components if funds are made available to the Panchayat.
